Summer Camp Accident Waiver and Release of Liability Form

I hereby give my permission for my child to participate in the Camp Wild Oaks program at Oak Hill School. I understand that Oak Hill School Staff and Camp Wild Oaks Staff are one in the same, and will be referenced interchangeably throughout this document.

I understand that Camp Wild Oaks program activities could include play and outdoor activities around and near the Oak Hill School grounds, hikes and walks in the woods wherein there could be mosquitos, bees, ticks, poison ivy, and slippery and jagged surfaces, among other dangers and risks.

I also understand that my child may travel by school bus and/or official volunteer vehicles to local sites and be walking along downtown streets and in public and private museums and historical sites.

I also understand that outdoor activities may occur in the hot sun, rain, and other outdoor elements. I agree to see that my child is appropriately attired for program activities, and to provide insect repellent and sunscreen for my child to use at the program. I will not expect the Camp Wild Oaks program to provide these items. I give my permission for Camp Wild Oaks program leaders to apply or assist with the application of the repellent and sunscreen I provide.

In the event of illness, injury, and/or accident, I authorize the Camp Wild Oaks program staff or any Oak Hill School employee to act on my behalf. They may approve any and all non-emergency or emergency treatment and are authorized to sign any and all medical release or required form(s) on my behalf. In the event of an emergency, I understand that I will be notified of the situation as soon as practicable. I agree to pay any necessary expenses not covered by Oak Hill School's student accident policy incurred in the medical treatment of my child, including, but not limited to all transportation costs to and from a medical facility, and, if necessary, transportation to my home or medical facility of choice.

I understand that Oak Hill School may, in its sole discretion, dismiss any Camp Wild Oaks program participant for inappropriate, disrespectful, or dangerous behavior at any time. In this event, I understand that I will not receive a refund of program fees for unattended days. If my child breaks or damages any property as a result of their direct or indirect behavior, I hereby agree to pay for its repair or replacement.

I understand that the risks associated with program activities could result in injury and/or death to my child. I hereby assume these risks and, knowing them, hereby give my child permission to participate. I understand that Oak Hill School is not liable for any injuries or other occurrences due to indoor and outdoor program activities or related risks, and/or the actions or omissions of Oak Hill School staff, volunteers, employees, trustees, directors, officers, or any other entities being released. I acknowledge that this Accident Waiver and Release of Liability Form will be used by the event holders, sponsors, and organizers of the activity in which my child may participate, and that it will govern the actions and responsibilities at said activity.

In consideration of my application and permitting my child to participate in this activity, I hereby: WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the Oak Hill School, its trustees, officers, employees, camp counselors, volunteers, entities or other persons released, for my child's death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to them including their traveling to and from this activity; INDEMNIFY and HOLD HARMLESS Oak Hill School, its trustees, officers, employees, volunteers, or other entities or persons released from any and all liabilities or claims made as a result of participation in this activity, whether caused by the negligence of release or otherwise. The Accident Waiver and Release of Liability Form shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law. Oak Hill School, its Trustees, directors, officers, and all its employees, acting officially or otherwise are hereby released from any and all claims, demands, actions, or causes of action on account of any injury to my child that may occur. This release binds my heirs, executors, administrators, and/or assigns.
