Payment Options:

Tuition Payment Plan A – One full payment of annual tuition due before September 1, 2023. If remittance is not made in full by the due date, a 6.75% finance fee on the balance will be assessed.

Tuition Payment Plan B – Full tuition amount spread over 10 monthly payments, each due on the first day of each month, September 1, 2023, through June 1, 2024 (includes 6.75% finance fee).

Tuition Payment Plan C – Full tuition amount spread over 12 monthly payments, each due on the first day of each month, July 1, 2023, through June 1, 2024 (includes 6.75% finance fee).

Financial Assistance:

Available for students entering grades K-8, tuition assistance is awarded based on demonstrated financial need and is made in the form of a grant applied as a reduction to the cost of tuition.

Families who can benefit from tuition assistance must apply each year.

Frequently Asked Questions:

1. What is financial assistance?

- At Oak Hill School, we believe that qualified families should have the opportunity to benefit from an Oak Hill education. Our financial assistance funding is intended to assist families with bridging the gap between income and their ability to pay education expenses.

- If you're a returning family, you'll use the same login credentials as last year.
- You will need to upload financial information, including tax information.

2. Who is eligible to apply for financial assistance?

- Financial assistance applications are open to both current families and families who are applying for admission into Oak Hill.

3. Will applying for financial assistance impact my admissions decision?

- Eligibility for financial assistance is based solely on need. Applying for financial assistance will in no way affect the consideration of your child into Oak Hill.

4. When is the deadline to apply for financial assistance?

- Financial assistance applications open on **November 1st** of each year. To be eligible for consideration for financial assistance, you must complete and submit all required documents by **the end of January**.
- Enrollment decisions will be sent out **by the end of March**. Families seeking financial assistance are encouraged to complete their application as early as possible.

5. Is financial assistance renewable each year?

- Yes, new applications for financial assistance and supporting documentation must be filed each year through the [SSS website](#).
- Your child's account must be kept current as financial standing is a factor in determining awards for subsequent years.

6. What is the average award for families?

- Financial assistance differs for families that apply and is based solely on need.
- If the need is there, and is confirmed by SSS, the range varies between 50%-80% of tuition cost.
