Dear Friends of Oak Hill School,

As the Treasurer and the Chair of the Finance Committee of Oak Hill School, I am pleased to share the financial report for the fiscal year ending June 30th, 2023. This report reflects the resilient financial position and performance of our school, thanks to the generous support of our staff, donors, parents, alumni and community partners. In the coming years, Oak Hill's anticipated growth will strengthen our working capital position, and I am very encouraged by the foundational steps taken in 2022-23 that will enable this to happen.

Many experts in the independent school community talk about the inflection point most schools face around their 30-year anniversary, where they are faced with the challenge to truly professionalize, grow, and solidify a vision for the long-term future. This began at Oak Hill in the 2022-23 year, and is continuing into 2024. We:

- Brought in an interim Head of School, Amelie Aust, for leadership reset and stabilization.
- Implemented a robust recruitment and hiring of our tremendous long-term Head of School, Pete Moore.
- Performed a complete digitization and review of the organization's accounting and financial platforms and processes, as well as staffing adjustments and improvements to our HR practices.
- Upgraded our website and communications platforms, supporting our community connection as well as future growth and recruitment.
- Enriched the student and family experience with investments in curriculum development, more assemblies and community events, and campus upgrades.

• Successfully raised \$250,000 to fund new playgrounds.

The financial report shows that our school had a total revenue of \$3.2 million and a total of expenses of \$3.6 million, resulting in a net loss from operations of \$0.4 million. Our revenue sources include tuition and fees, donations, grants, and other income. Our expenses include salaries and benefits, instructional costs, facilities and maintenance, administration, and depreciation. The net loss was covered by the reserve fund from the pandemic grants (PPP, ERC) received in the prior two years.


Our school also has a healthy balance sheet, with total assets of \$8.2 million and total liabilities of \$0.9 million, resulting in a net asset of \$7.3 million. Our assets include cash and investments, accounts receivable, prepaid expenses, and property and equipment. Our liabilities include accounts payable, accrued expenses, deferred revenue, and long-term debt.

We are grateful for the trust and confidence that our staff, donors, parents, alumni, and community partners have placed in our school. With our efforts to increase enrollment and streamline expenses in our new budgeting framework, we are committed to ensuring the financial sustainability and accountability of our school, as well as the excellence and innovation of our education and services. We look forward to continuing our partnership with you in the coming year.




Below is a breakdown of functional expenses.




Total Functional Expenses

These expenses are further broken down to different expense categories within these overall functional categories.







